

## British Council in Japan IELTS Prize 2025 Campaign

- (1) **Application:** your application should be accurate, not omit any facts that are relevant and not be misleading. If we find that there are significant errors or omissions in the information you have supplied to us in the course of your application you will not be offered the British Council in Japan IELTS Prize 2025, or you will have your offered the British Council in Japan IELTS Prize 2025 withdrawn or terminated.
- (2) **Eligibility:** British Council in Japan IELTS Prize 2025 Campaign.
- Resident status:** You must be a legal resident of Japan. You should, therefore, submit photo copy of passport along with a application for the prize. Those who hold non-Japanese nationality, you must submit evidence of Japan residence. (Foreign residence card) along with this application form.
  - Age:** 18 years or above.
  - IELTS examinations:** Have taken IELTS with the British Council including its official test centres (JP500, JP512, JP223) between 1 April and 31 July 2025 and be able to produce a valid IELTS score in the application. (please count sufficient days required to get Test Report Form before closing date of this campaign.)
  - Type of IELTS :** Regular IELTS, IELTS for UKVI, Academic Module, General Training Module, IELTS on Paper, IELTS on Computer are eligible.
  - IELTS score:** Have a minimum overall IELTS band score of 5.5 or above.
  - Be applying to an educational institution anywhere in the world. Undergraduate, Post graduate, short term exchange student, domestic educational institutions in Japan which requires IELTS for their entrance exam are eligible.
  - Those who have taken IELTS to get legal visa for the immigration and/or work permission are eligible.
  - Only one application per person per one applicable period (see section (3)-b below) is allowed.
  - Entry to British Council in Japan IELTS Prize 2025 is free of charge although applicants are responsible for their own costs of connecting to the internet.
- (3) **British Council in Japan IELTS Prize 2025 dates:**
- The opening date of IELTS Prize 2025 in Japan is 00:00 JST on 1 May 2025 and the closing date is at 23:59 JST on 31 July 2025.
  - There are 3 separate application period during the entire period. Each application period has separate starting date and closing date. Please refer to the schedule below.

2nd application period	1 June 2025 (0:00 JST)	30 June 2025 (23:59 JST)
3rd application period	1 July 2025 (0:00 JST)	31 July 2025 (23:59 JST)

Any entry received before the opening date or after the closing date of each application period will not be included in the selection process that has been applied. Those who applied in the three months from May 1st to July 31st by the end of May and June will have the right to be selected until the end of July, and those who were not selected in each month will be automatically given another chance to be selected. The British Council accepts no responsibility whatsoever for any technical failure or malfunction or any other problem with any system, server, provider or otherwise that may result in any entry being lost, delayed or not properly registered.

- (4) **Entry clearance:** you must tell us when you apply if there is anything (such as previous convictions or associations with terrorist organisations) that may be an impediment to securing a visa or entry clearance to study overseas. If for any reason you cannot obtain a visa to study in the desired country of study, then the British Council may withdraw the offer of a prize. You should not make commitments, especially commitments with financial consequences, unless you are certain that there will be no impediment to you securing a visa or entry clearance to study or work.
- (5) **Selection:** the selection process will be fair. No applicant will have, or should seek or accept, any unfair advantage. If we find that you have secured an unfair advantage in the selection process we reserve the right not to offer you a offered the British Council in Japan IELTS Prize 2025, or withdraw or terminate your offer to the British Council in Japan IELTS Prize 2025.
- (6) **All three (3) IELTS Prize winners** will be announced after the final selection at the end of July. This notification will be made to the email address provided by the winning applicant when registering for British Council IELTS Prize. In this notification, the British Council will inform each IELTS Prize winner of how to claim their prize and of any additional information or steps required to enable the British Council to provide them with the prize. The British Council reserves the right to award the relevant prize to another IELTS Prize applicant if the prize is not claimed within three weeks after such notification.
- (7) **Commitment:** If you receive the IELTS Prize, you agree to become an IELTS ambassador to share your study experience with others in talks / seminars / SNS / website / feature in video clip(s) for the promotion of the IELTS scholarship. You will also need to provide testimonials and photos, which may be published or used by the British Council for IELTS promotion purposes.

- (8) **Offer withdrawal:** British Council reserves the right to withdraw the offer of an IELTS Prize if in its sole determination it believes that the circumstances are such that this is in the best interests of the applicant or British Council.
- (9) All rights to the documents and work submitted for the IELTS Prize 2025 in Japan application, including the original video, belong to the British Council in Japan. In addition, submitted documents and work (including videos) will not be returned.
